2. IDENTIFICATION OF THE PREPARATION / COMPOSITION / INFORMATION ON INGREDIENTS

Nonionic surfactant (Cocamide DEA, Polyethylene glycol isononylphenyl ether), Phosphoric Acid, Disinfectant (Benzalkonium Chloride), Formaldehyde; Thickening Agent (Xantham Gum), aqua, Perfume (Fresh, pine), Coloring Agent (CI.42090; CI.42090 & CI.47005)

3. HAZARDS IDENTIFICATION

R36/37/38: Irritant for respiratory system, eyes and skin.
